Notification

The matter relating to applicability of EPM rate contract to the projects undertaken by the State Government and the instrumentality under it viz Govt. Departments/ PSUs/Local Bodies on turnkey/composite tender basis has been under consideration of the Government for some time past.

The State Government after careful consideration have decided that the State Government or its instrumentality viz Govt. Departments/PSUs/Local Bodies whenever go for execution of any contract on turnkey/composite tender basis they must see that a stipulation is incorporated in the tender paper and contract asking the successful bidder to purchase materials necessary for execution of the work contract from EPM rate contract holders having ISI mark so that the interest of the SSI units and Micro & Small Enterprises is protected.

While finalising the payment, the concerned Department/PSU/Local Body may ensure that the payment to the local MSEs have been made by the concerned agency executing the project.
